

Terms of Service

Welcome to PlusMoneyMakers ("PlusMoneyMakers", "we", "us", or "our"). These Terms of Service ("Terms") govern your access to and use of the website located at plusmoneymakers.com, including all subdomains, content, tools, and any related services (collectively, the "Service"). By accessing or using the Service you agree to be bound by these Terms. If you do not agree, do not use the Service.

1. Eligibility

You must be at least **21 years of age** (or the legal gambling age in your jurisdiction, whichever is greater) and legally permitted to receive sports handicapping information and to place wagers in the jurisdiction where you reside. You are solely responsible for determining whether your use of the Service is lawful in your location. The Service is intended for use only where permitted by applicable law.

2. Nature of the Service — Information Only

We publish sports analysis, opinions, statistics, historical performance data, and picks ("Content"). **We are not a sportsbook, bookmaker, casino, or gambling operator.** We do not accept, place, facilitate, or process wagers of any kind. No money is ever wagered on this site.

Any decision you make to place a wager with a licensed sportsbook based on Content is made solely at your own discretion and risk. See our Disclaimer for details.

3. Accounts

To access certain features you may need to create an account. You agree to provide accurate information, keep your credentials secure, and be responsible for all activity under your account. You must notify us promptly of any unauthorized use. We may suspend or terminate accounts that violate these Terms or that we reasonably suspect of fraud, abuse, or unlawful activity.

4. Subscriptions, Billing, and Refunds

- Paid subscriptions renew automatically at the price and interval disclosed at checkout until cancelled.
- You may cancel at any time from your account page; cancellation stops future renewals but does not refund the current billing period.
- All fees are quoted in U.S. dollars and are non-refundable except where required by law or expressly offered in writing by us.
- Prices, features, and promotional offers may change; changes apply on the next billing cycle.
